

Promotion Rules May Long Weekend in the Wild West

§1 General Provisions of the Promotion

1. The organizer of the promotion covering accommodation services and additional benefits at the Western Camp resort in Zator, hereinafter referred to as the "Promotion," is the company under the name MG GOCZAŁ Sp. z o.o. with its registered office in Zator, ul. Oświęcimska 35, 32-640 Zator, registered in the entrepreneurs register by the District Court for Kraków – Śródmieście in Kraków, XII Economic Department of the National Court Register under the KRS number: 0000970405, NIP: 5492467107, REGON: 521948419, share capital – PLN 100,000.00, hereinafter referred to as the "Organizer."
2. Participant – a participant of the Promotion who meets all the conditions for participating in the Promotion, as specified in these Regulations.
3. Regulations – these Promotion rules.
4. The Promotion is organized within the territory of the Republic of Poland, and participation in it is voluntary.
5. The Promotion cannot be combined with other promotions.

§2 Conditions for Using the Promotion

1. The Promotion is intended exclusively for individuals (consumers within the meaning of Article 22(1) of the Civil Code) located within the territory of the Republic of Poland, who, on the day of joining the Promotion, have full legal capacity and meet the other provisions and conditions of the Regulations.
2. The Promotion does not include school, group, or corporate reservations.
3. By joining the Promotion, the Participant acknowledges that they have read the contents of the Regulations, agree to comply with the rules specified in the Regulations, and confirm that they meet the conditions entitling them to participate in the Promotion.

5. Duration of the Promotion/conditions for using the Promotion: a. Reservations (including payment) must be made from March 26, 2024, to April 21, 2024, inclusive; b. The reservation must cover stays from April 26, 2024, to May 5, 2024 (in the case of stays longer than one day – the last day of the stay (checkout date) must end no later than May 6, 2024).

§3 Scope of the Promotion

1. As part of the Promotion, the Participant is entitled to purchase a package consisting of accommodation services and an entrance ticket to the Energylandia Amusement Park in Zator at a reduced price:

HOUSEBOATS BELOW 140CM (Reduced-rate two-day ticket)	579PLN

2. The entrance ticket to the Energylandia Amusement Park is valid until June 21, 2024 (the expiry/use-by date of the ticket). Details of using the ticket are in accordance with the regulations of the Energylandia Amusement Park in Zator: <https://energylandia.pl/o-nas/regulamin-parku/>.
3. Reservations are not subject to further resale/exchange.
4. The Promotion reservation includes all individual accommodations: in cabins, tipis, wagons, and water cabins.
5. The accommodation reservation is non-refundable and cannot be rescheduled. The reservation must cover a minimum of 2 nights.
6. The Organizer reserves the right to verify the Participant's eligibility to use the Promotion.

§4 Final Provisions

2. The Organizer reserves the right to make changes to these Regulations at any time without giving a reason. However, changes to the Regulations may not violate the rights acquired by the Participants.
