# Promotion of ticket sales to Energylandia Amusement Park

with a discount along with Fast Pass for 1 PLN.

#### I. GENERAL PROVISIONS

- 1. The organizer of the promotion in the form of ticket sales to Energylandia Amusement Park with a discount along with Fast Pass for 1 PLN entrance without queue to specific attractions of Energylandia Amusement Park hereinafter referred to as the "Promotion" is MG GOCZAŁ Sp. z o.o. with its registered office in Zator, ul. Oświęcimska 35, 32-640 Zator, registered in the register of entrepreneurs by the District Court for Kraków Śródmieście in Kraków, XII Economic Department of the National Court Register under the KRS number: 0000970405, NIP: 5492467107, REGON: 521948419, share capital PLN 100,000.00, tel. +48 33 482 03 80, 885 044 747, email: recepcja@westerncamp.pl, operating the Western Camp Resort facility, hereinafter referred to as the "Organizer."
- 2. Participant a person meeting the conditions specified in point II of the Regulations.
- 3. Regulations these regulations of the Promotion.
- 4. Promotion this promotion organized under the name "FAST PASS for 1 PLN ENERGYLANDIA."
- 5. The purpose of the Promotion is to enable Customers of the Western Camp Resort facility to actively spend time in Energylandia Amusement Park and use specific attractions on the basis of priority, in accordance with the rules specified in these Regulations and the instructions applicable to these attractions.
- 6. The Promotion is valid until further notice.
- 7. The Promotion is organized in the territory of the Republic of Poland, and participation in it is voluntary.
- 8. The Promotion cannot be combined with other promotions applicable at Energylandia Amusement Park.
  - II. RULES FOR PURCHASING PROMOTIONAL TICKETS ALONG WITH FAST PASS for 1 PLN
- 1. Promotional tickets can be purchased by Guests of the Western Camp Resort facility (individuals who have booked accommodation at the facility). Tickets can be purchased at the reception of the facility.
- 2. Promotional tickets with Fast Pass for 1 PLN to Energylandia Amusement Park for individual clients are sold with a 5% discount, compared to the base prices of tickets (without special promotions) applicable at Energylandia Amusement Park on the day of purchase. 2.1 Group and school promotional tickets with Fast Pass for 1 PLN to Energylandia Amusement Park are sold at the base price applicable at the Family Amusement Park Energylandia.
- 3. Payment for promotional tickets to Energylandia Amusement Park is made by credit card, cash, or bank transfer.
- 4. Promotional tickets to Energylandia Amusement Park are issued to Guests of the Western Camp Resort facility in paper form.

- Promotional tickets can be used during their validity period, according to the opening calendar of the Park located on the Energylandia Amusement Park website www.energylandia.pl
- 6. There is no possibility of returning a promotional ticket.
- 7. Fast Pass for 1 PLN is a supplement/addition to the promotional ticket purchased at the Western Camp Resort facility by Guests who have booked accommodation at Western Camp Resort. Obtaining Fast Pass by a Guest of the Western Camp Resort facility entails an additional fee of 1 PLN per 1 Fast Pass.
- 8. Fast Pass for 1 PLN is issued in paper form simultaneously with the issuance of the ticket purchased by the Guest at the reception of Western Camp Resort.
- The following types of Fast Passes for 1 PLN are valid:
  9a. Normal Fast Pass, valid for roller coasters Hyperion, Zadra, Mayan, Abyssus, Choco Chip Creek issued for tickets:
- one-day individual for persons over 140 cm in height (1 Fast Pass for 1 ticket),
- two-day individual for persons over 140 cm in height (2 Fast Passes for 1 PLN with a total value of 2 PLN for 1 ticket)
- school tickets for grades I-VI, VII -VIII (1 Fast Pass for 1 ticket)
- tickets for high school and university students (1 Fast Pass for 1 ticket)
- group tickets for adults (1 Fast Pass for 1 ticket)
  - 9b. Reduced Fast Pass, valid for roller coasters Abyssus and Choco Chip Creek issued for tickets:
- one-day individual for persons under 140 cm in height (1 Fast Pass for 1 ticket)
- two-day individual for persons under 140 cm in height (2 Fast Passes for 1 PLN with a total value of 2 PLN for 1 ticket)
- preschool tickets (1 Fast Pass for 1 ticket)
- 10. There is no possibility of purchasing a Fast Pass for 1 PLN for tickets for children under 3 years old.
- 11. Fast Pass entitles you to one entry through priority gates in Energylandia Amusement Park marked with the Western Camp logo on the attractions:
- for the Normal Fast Pass: Zadra, Hyperion, Mayan, Abyssus, Choco Chip Creek.
- for the Reduced Fast Pass: Abyssus, Choco Chip Creek.
- 12. In the case of a Guest purchasing a one-day ticket over 140cm in height, school ticket, for supervisors of school groups, and group tickets specified in point 9a, Fast Pass for 1 PLN includes 1 entry to Zadra, 1 entry to Hyperion, 1 entry to Mayan, 1 entry to Abyssus, 1 entry to Choco Chip Creek. In the case of purchasing two-day tickets for persons over 140cm in height, Fast Pass for 2 PLN includes 1 entry to Zadra, 1 entry to Hyperion, 1 entry to Mayan, 1 entry to Abyssus, 1 entry to Choco Chip Creek within two consecutive days of stay in Energylandia Amusement Park.

12a. In the case of a Guest purchasing a one-day ticket for persons under 140cm in height and for preschools, Fast Pass for 1 PLN includes 1 entry to Abyssus and 1 entry to Choco Chip Creek.

12b. In the case of a Guest purchasing a two-day ticket for persons under 140cm in height, Fast Pass for 2 PLN includes 1 entry to Abyssus and 1 entry to Choco Chip Creek within two consecutive days of stay.

- 13. When using Fast Pass, one should follow the information provided at the respective attraction.
- 14. Fast Pass for 1 PLN is valid for a period of 3 days from the day of receipt. Each Fast Pass can only be used once.
- 15. There is no possibility of obtaining an additional Fast Pass for 1 PLN in case of loss or damage.
- 16. Promotional tickets and Fast Passes for 1 PLN cannot be further resold or exchanged for another type or kind of ticket.
- 17. The reception of the Western Camp Resort facility is not responsible for the loss or damage of the promotional ticket to Energylandia Amusement Park and/or the Fast Pass supplement for 1 PLN.
- 18. The promotional ticket allows the use of all available attractions at any given time according to the rules applicable at Energylandia Amusement Park. Due to safety reasons and the prevailing situation, some attractions of Energylandia Amusement Park may be excluded.
- 19. The Promotion may be canceled at any time by the Organizer.

### III. TERMS OF PARTICIPATION IN THE PROMOTION

- The Promotion is intended for individuals who, on the day of joining the Promotion, have reached the age of 18 and meet the other provisions and conditions of the Regulations (consumers within the meaning of art. 22 of the Civil Code) and legal entities.
- 2. The Participant's participation in the Promotion means that they have familiarized themselves with the content of the Regulations, undertake to comply with the rules specified in the Regulations, and confirm that they meet the conditions entitling them to participate in the Promotion.
- 3. To participate in the promotion, one must book accommodation at the Western Camp Resort facility, and then purchase a ticket and Fast Pass at the reception of the Western Camp Resort facility.

# IV. PERSONAL DATA

- 1. The Organizer is the administrator of personal data provided by Participants.
- 2. Providing personal data by Participants is voluntary.
- 3. Personal data of Participants will be used only for operational purposes related to the Promotion. The Participant has the right to access their data.
- 4. The Organizer does not sell or disclose Participants' personal data to other entities.
- 5. Detailed rules for the processing of personal data are available on the website www.westerncamp.pl.

#### V. COMPLAINTS

- Western Camp Resort is not responsible for the inability to use the Fast Pass supplement for 1 PLN due to technical reasons occurring at the Energylandia Amusement Park. In case of inability to use the Fast Pass for 1 PLN, this fact should be reported to the staff of Energylandia Amusement Park.
- 2. Other complaints regarding the conduct of the Promotion should be submitted in writing at the reception of the Western Camp Resort facility in Zator, ul. Oświęcimska 35, 32-640 Zator, or by sending an email to: recepcja@westerncamp.pl. A complaint form is available at the reception of the facility.
- 3. A written complaint should include the name, surname, and exact address of the Participant, the original ticket and/or Fast Pass, proof of purchase, and a detailed description and justification of the complaint.
- 4. Complaints will be considered by the Organizer in accordance with the applicable law within 14 days from the date of receipt.
- 5. The Participant will be informed about the method of handling the complaint by email to the email address provided in the complaint.
- 6. MG GOCZAŁ Sp. z o.o. is not responsible for Fast Passes purchased at a location other than the reception of Western Camp Resort (ul. Oświęcimska 35, 32-640 Zator).

## VI. FINAL PROVISIONS

- 2. The Organizer reserves the right to make changes to this Regulation at any time without giving a reason. However, changes to the regulations cannot violate the rights acquired by the Participants.
