Swimming Pool Area Rules and Rules for the Pool at Western Camp Resort

- 1. The pool is available to guests using the hotel services. Accommodation at Western Camp Resort entitles you to free use of the pool and is equivalent to familiarizing yourself with and accepting the provisions of this regulation and the facility's regulations.
- 2. The use of the facility is only permitted in the presence of a lifeguard. Before entering the pool, users are required to leave outer garments and footwear by the poolside or on the loungers next to the pool.
- 3. Admission to the pool is only possible in commonly accepted swimwear suitable for pool water, i.e.,:
- women one or two-piece swimsuit without straps
- men close-fitting swim trunks without pockets and belts.
 - 4. Children under 3 years old may only use the pool in special diaper pants.
 - 5. In the accommodation facility, devices that may be damaged (phones, watches, etc.) and items with sharp edges that may pose a threat (jewelry) must be left behind. It is recommended to leave valuable items in the accommodation facilities. Western Camp Resort management or staff are not responsible for lost or stolen items.
 - 6. Before using the pool complex, it is necessary to thoroughly wash the body under the shower, i.e., a private bathroom attached to each cottage or public toilets available to guests of the facility.
 - 7. After using the toilets on the premises, it is obligatory to thoroughly wash the body under the shower before entering the pool.
 - 8. Children and adolescents under 13 years of age are not allowed to use the pool complex without adult supervision.
 - 9. The following persons are not allowed to use the pool:
- those in poor health, which may pose a risk to themselves or others using the pool,
- those suffering from upper respiratory tract diseases or having difficulty breathing
- those with unhealed wounds or skin diseases e.g., fungus, ringworm
- those suffering from epilepsy or infectious diseases
- those allergic to disinfectants or chlorine
- those suffering from cardiovascular diseases
- those with urinary system disorders.
 - 10. Persons with reduced mobility and pregnant women should use the pool with particular caution. Western Camp Resort is not responsible for the consequences of using the pool by these individuals.
 - 11. It is strictly prohibited in the pool area:
- bringing alcoholic beverages and food items,

- bringing glass containers, sharp objects, and other dangerous items (including cosmetics in glass containers)
- chewing gum in the entire pool area,
- · smoking,
- consuming drinks and meals while in the pool, polluting and throwing any objects into the water
- jumping into the pool,
- pushing or throwing other users into the water,
- relieving oneself in the pool,
- using vulgar language,
- bringing in and having animals,
- admitting persons whose condition indicates heavy alcohol intoxication or under the influence of other intoxicating substances,
- admitting persons whose health condition may pose a drowning risk and endanger the health of other pool users,
- lending lifeguard equipment for purposes other than intended,
- initiating false alarms.
 - 12. In the case of organized groups, the guardian of the group is responsible for the consequences of the participants' behavior.
 - 13. A person who intentionally or unintentionally contaminates the pool will be charged for the cost of water replacement in the pool. In the case of children, the guardian of the child is responsible.
 - 14. Any injuries or other irregularities should be reported immediately to the COLD SHOP employee.
 - 15. Staff may temporarily restrict access to the pool due to the number of people present.
 - 16. Persons not complying with the pool usage regulations and the facility's regulations will be removed from the pool area without the possibility of re-entry.
 - 17. Adherence to orders, prohibitions, warnings, instructions, and information in the form of symbols and text posted on signs throughout the pool area is required they constitute an extension of this regulation and are part of it.

In case of disputes, the Regulations of the Western Camp Resort Facility shall apply.
