

**Promotion Terms and Conditions**  
**Free Accommodation with Breakfast for Children up to 12 Years Old**

**§1**

**General Provisions of the Promotion**

1. The organizer of the promotion in the form of reduced accommodation service prices at the Western Camp resort in Zator, hereinafter referred to as the "Promotion," is MG GOCZAŁ Sp. z o.o., with its registered office in Zator, ul. Oświęcimska 35, 32-640 Zator, entered into the Register of Entrepreneurs by the District Court for Kraków-Śródmieście in Kraków, 12th Commercial Division of the National Court Register under KRS number: 0000970405, NIP: 5492467107, REGON: 521948419, share capital – PLN 100,000.00, hereinafter referred to as the "Organizer."
2. Participant – a person participating in the Promotion who meets all participation conditions outlined in these Terms and Conditions.
3. Terms and Conditions – these Promotion Terms and Conditions.
4. The Promotion is organized within the territory of the Republic of Poland, and participation is voluntary.
5. The Promotion cannot be combined with other promotions.

**§2**

**Conditions for Participation in the Promotion**

1. The Promotion is intended solely for natural persons (consumers within the meaning of Article 22(1) of the Civil Code) located within the territory of the Republic of Poland, who, on the date of joining the Promotion, have full legal capacity and meet the other provisions and conditions of these Terms and Conditions.
2. The Promotion does not apply to school, group, or corporate bookings.
3. By participating in the Promotion, the Participant confirms that they have read these Terms and Conditions, agree to abide by them, and confirm that they meet the eligibility requirements to participate in the Promotion.
4. To participate in the Promotion, a reservation must be made at the Western Camp resort via email at [recepja@westerncamp.pl](mailto:recepja@westerncamp.pl) or by phone at +48 334820380 or +48 885044747, and paid for in accordance with the "Western Camp Booking Terms and Conditions."
5. Promotion period:
  - a. The reservation (including payment) must be made by **June 15, 2025**, inclusive.
  - b. The promotional rate applies to stays from **June 5, 2025**, to **June 30, 2025**,

excluding overnight stays from **June 18–21, 2025** (if the stay is longer than one night, the last day of the stay — check-out date — must be **no later than July 1, 2025**).

### **§3**

#### **Scope of the Promotion**

1. Reservations cannot be resold or rescheduled.
2. The Promotion applies to all individual overnight stays: in a sheriff's cabin, Indian tipi, cowboy wagon, or houseboat.
3. The offer is valid for reservations including **two adults** in a cabin, tipi, wagon, or houseboat. **Children up to 12 years old stay and have breakfast free of charge.**
