

**Promotion Terms and Conditions**  
**Accommodation at Western Camp Resort + 3-Day Ticket to Energylandia Amusement Park**

**§1**

**General Provisions of the Promotion**

1. The organizer of the promotion covering accommodation services and additional benefits at the Western Camp Resort in Zator (hereinafter referred to as the "Promotion") is MG GOCZAŁ Sp. z o.o., with its registered office in Zator, ul. Oświęcimska 35, 32-640 Zator, entered into the Register of Entrepreneurs kept by the District Court for Kraków–Śródmieście in Kraków, 12th Commercial Division of the National Court Register under KRS number: 0000970405, NIP: 5492467107, REGON: 521948419, with share capital of PLN 100,000.00, hereinafter referred to as the "Organizer".
2. Participant – a participant of the Promotion who meets all the conditions specified in these Terms and Conditions.
3. Terms and Conditions – these Promotion Terms and Conditions.
4. The Promotion is organized within the territory of the Republic of Poland, and participation is voluntary.
5. The Promotion cannot be combined with other promotions.

**§2**

**Conditions for Participation in the Promotion**

1. The Promotion is intended exclusively for natural persons (consumers within the meaning of Article 22(1) of the Polish Civil Code) residing in the Republic of Poland who, on the date of joining the Promotion, have full legal capacity and meet the remaining provisions and conditions set out in these Terms and Conditions.
2. The Promotion does not apply to school, group, or corporate reservations.
3. By joining the Promotion, the Participant confirms that they have read these Terms and Conditions, agree to comply with them, and confirm that they meet all the requirements entitling them to participate in the Promotion.
4. To participate in the Promotion, a reservation must be made at the Western Camp Resort via phone at +48 334820380 or +48 885044747, or by email at [recepja@westerncamp.pl](mailto:recepja@westerncamp.pl), and must be paid for in accordance with the "Western Camp Reservation Terms and Conditions."

5. Promotion duration / conditions:
- a. The reservation (including payment) must be made no later than **August 31, 2025**;
  - b. The reservation must cover a stay taking place no later than **August 31, 2025** (if the stay exceeds one day, the last day – check-out date – must fall no later than **September 1, 2025**).

### §3

#### Scope of the Promotion

1. Under the Promotion, the Participant is entitled to purchase a package consisting of accommodation services and a 3-day admission ticket to Energylandia Amusement Park in Zator at a discounted price:

*Price per person for a 3-night stay including a 3-day ticket to Energylandia.*

2. The ticket to Energylandia Amusement Park is valid until **October 26, 2025** (final date of validity/use). Use of the ticket is subject to the terms of the Park's regulations available at: <https://energylandia.pl/o-nas/regulamin-parku/>
3. Reservations made under the Promotion are non-transferable and may not be resold or exchanged.
4. The Promotion applies to all individual accommodation types: cabins, tipis, wagons, and houseboats.
5. Reservations under the Promotion are **non-refundable and cannot be rescheduled**. A minimum stay of **3 nights** is required.
6. The Organizer reserves the right to verify a Participant's eligibility for the Promotion.
7. The minimum number of people per accommodation unit per night (cabin for 4 or 6, tipi, wagon, houseboat) under this Promotion is **2 persons**.
