#### **REGULATIONS**

for renting a game console within the premises of Western Camp in Zator

## § 1 Subject of the Agreement

- 1. These Regulations set out the general terms and conditions of the loan (rental) of a PlayStation 5 console together with the equipment necessary for its use (hereinafter collectively referred to as the "Console" or "Consoles") within the premises of Western Camp in Zator.
- 2. By signing the Console Rental Protocol, which constitutes Annex No. 1 to these Regulations, the Guest confirms having read these Regulations and concludes an agreement under which Western Camp permits the Guest to use the Console for the period specified in the Console Rental Protocol.
- 3. For the purposes of these Regulations, a Guest is understood as an adult natural person using accommodation services at Western Camp.
- 4. The Consoles subject to rental are the property of MG Goczał sp. z o.o. with its registered office in Zator (32-640), ul. Oświęcimska 35, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for Kraków-Śródmieście in Kraków, 12th Commercial Division of the National Court Register under KRS number: 0000970405, REGON: 521948419, NIP: 5492467107, e-mail: recepcja@westerncamp.pl, tel.: +48 885 044 747 (hereinafter: "Western Camp").

#### § 2 Rules

- 1. Rental and return of the Console take place at the reception of Western Camp.
- 2. The rental of the Console is free of charge.
- 3. A prerequisite for renting the Console is signing the Console Rental Protocol.
- 4. Due to the limited number of Consoles, Western Camp does not guarantee their availability at the time chosen by the Guest.
- 5. The Console is rented for the fixed period indicated in the Console Rental Protocol. The Guest may request at the reception to extend the rental period no later than 10 minutes before the original rental period expires, provided that the extension is possible only if the Console is available at the requested time. If an extension is not possible due to unavailability, the Guest is obliged to return the Console no later than 5 minutes after the rental period indicated in the Console Rental Protocol has expired.
- 6. The Console may only be used within the premises of Western Camp by its Guest. It is prohibited to take the Console outside the premises of Western Camp or to hand it over to third parties (persons who are not Guests of Western Camp).
- 7. Western Camp permits connecting the Console to devices owned by the Guest, but prior to rental the Guest must ensure that their equipment allows proper connection and use of the Console.
- 8. Western Camp provides the Guest with a PlayStation account, the necessary details of which are specified in the Console Rental Protocol. A list of installed games is available at the reception. The Guest is not allowed to install new games using the provided account.

## § 3 Liability

- 1. The Guest is obliged to read the Console's user manual and to use it in accordance with the manual and its intended purpose.
- 2. The Guest should regularly monitor the technical condition of the Console and immediately report any issues with its operation.
- 3. The Guest is fully liable for any damage caused by improper use of the Console, its destruction (total or partial), or loss.
- 4. Failure to return the Console despite the obligation to do so after the rental period has expired may give rise to criminal liability for misappropriation.

#### § 4 Personal Data

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: "GDPR"), Western Camp informs that:

- 1. The controller of the Guest's personal data is Western Camp (full details of the Controller in § 1 section 4 of the Regulations).
- 2. Personal data will be processed for the performance of the Agreement pursuant to Art. 6(1)(b) GDPR, and for the establishment, exercise, or defense of legal claims pursuant to Art. 6(1)(f) GDPR.
- 3. The scope of processed personal data may include the personal identification and contact details provided by the Guest, i.e., first name, surname, correspondence address, and telephone number.
- 4. Recipients of personal data may include authorized employees of the Controller, entities providing services to the Controller, in particular IT service providers, consulting companies, and legal services as processors, as well as other entities when disclosure is required by law.
- 5. Personal data will be processed for the period necessary to perform the Agreement, to pursue claims related to the Agreement, or to defend against claims, or for the period resulting from applicable legal regulations (including tax laws), whichever period expires later.
- 6. Subject to legal restrictions, the data subject has the right to access their data, and the right to rectification, erasure, restriction of processing, objection to processing, data portability, as well as the right to lodge a complaint with the President of the Personal Data Protection Office. The scope of these rights and the situations in which they may be exercised are set out in the GDPR.
- 7. Providing personal data is voluntary but necessary to conclude and properly perform the Agreement.
- 8. Personal data will not be processed by automated means or subject to profiling.

#### § 5 Final Provisions

- 1. In matters not regulated by these Regulations, the relevant provisions of generally applicable law, including the Civil Code, shall apply.
- 2. These Regulations apply to agreements concluded from 17 September 2025.
- 3. Annex: Console Rental Protocol constitutes an integral part of the Regulations.
