

Promotion Terms and Conditions

Accommodation at Western Camp Resort + 3 Days of Fun at Energylandia + 1 Energy Pass

§1

General Provisions of the Promotion

1. The organizer of the promotion covering accommodation services and additional benefits at Western Camp Resort in Zator, hereinafter referred to as the "Promotion", is MG GOCZAŁ Sp. z o.o., with its registered office in Zator, ul. Oświęcimska 35, 32-640 Zator, entered into the Register of Entrepreneurs maintained by the District Court for Kraków-Śródmieście in Kraków, 12th Commercial Division of the National Court Register under KRS number: 0000970405, NIP: 5492467107, REGON: 521948419, share capital: PLN 100,000.00, hereinafter referred to as the "Organizer".
2. Participant – a participant of the Promotion who jointly fulfills all participation conditions specified in these Terms and Conditions.
3. Terms and Conditions – these Promotion Terms and Conditions.
4. The Promotion is organized within the territory of the Republic of Poland and participation in it is voluntary.
5. The Promotion cannot be combined with other promotions.

§2

Conditions for Participation in the Promotion

1. The Promotion is intended exclusively for natural persons (consumers within the meaning of Article 22(1) of the Polish Civil Code) residing within the territory of the Republic of Poland, who at the time of joining the Promotion have full legal capacity and fulfill the remaining provisions and conditions specified in these Terms and Conditions.
2. The Promotion does not apply to school, group, or corporate reservations.
3. By joining the Promotion, the Participant confirms that they have read these Terms and Conditions, undertake to comply with the rules specified herein, and confirm that they fulfill the conditions entitling them to participate in the Promotion.
4. In order to participate in the Promotion, a reservation must be made at Western Camp Resort by phone at +48 33 482 03 80 or +48 885 044 747, or by e-mail at recepcja@westerncamp.pl, and paid for in accordance with the "Western Camp Reservation Terms and Conditions".
5. Promotion period / conditions for participation in the Promotion:
 - a. the reservation (including payment) must be made between 14.05.2026 and 31.08.2026 inclusive;
 - b. the reservation must include a stay taking place no later than 31 August 2026 (if the stay lasts longer than one day, the final day of the stay/check-out date must be no later than 1 September 2026).

Scope of the Promotion

1. Under the Promotion, the Participant is entitled to purchase a package consisting of accommodation services and an admission ticket to Energylandia at a reduced price:

2. The admission ticket to Energylandia is valid until 31 October 2026 (final validity/use date of the ticket). Detailed ticket usage conditions are specified in the park regulations available at: Energylandia Park Regulations

3. Reservations may not be resold or exchanged.

4. Reservations covered by the Promotion apply to all individual accommodation options: cottages, tipis, wagons, and houseboats.

5. Accommodation reservations are non-refundable and cannot be rescheduled. The reservation must include a minimum stay of 3 nights.

6. The Organizer reserves the right to verify the Participant's eligibility to use the Promotion.

7. The minimum number of guests per accommodation unit per night (6-person cottage, 4-person cottage, tipi, wagon, houseboat) under this Promotion is 2 persons.

8. As part of the Promotion, for each purchased regular 3-day ticket, the Participant receives 1 (one) Energy Pass entitling them to one-time priority access to the following attractions at Energylandia: Pepsi Hyperion, Zadra Made In Małopolska, Mayan Zero Limitów, Abyssus, Choco Chip Creek, Toffifee Kopalnia Złota, Space Booster, Śmiejęłki Energuś, Anaconda, Aztec Swing, Formula, Speed Water Coaster, RMF Dragon, and Tsunami Drop. For each purchased reduced 3-day ticket, the Participant receives 1 (one) Energy Pass entitling them to one-time priority access to the following attractions at Energylandia: Abyssus, Choco Chip Creek, Toffifee Kopalnia Złota, Śmiejęłki Energuś, Anaconda, Formula, RMF Dragon, and Tsunami Drop.
